RULES, REGULATIONS AND PROCEDURES FOR CULTURAL PROGRAM PARTICIPATION

The participants agree to abide by the following rules, regulations and procedures with the recognition that it is intended to give everyone a fair opportunity to perform their items. Further, participants agree to abide by any special instructions oral or written, if necessary to accommodate unanticipated circumstances and last minute changes.

1. Participation is open to all performing Indian cultural items.
2. Separate form must be used for each item.
3. Usable performing area of the stage is 24(W), 12(D), and 8(H) and must be considered in selection of number of participants.
4. Each item should be between 7 to 10 minutes. Items longer than this time will not be used except with prior arrangement.
5. Each item must be on a separate CD. The audio CD must be labeled to identify for the item to be performed with indication of track number of the item. This audio CD must be submitted to or alternative arrangements made with Cultural Chair **by Wednesday, July 11, 2018**
6. Participants are expected to arrive at least two hours prior to their time block issued. No one will receive a specific time.
7. It is the group leader's responsibility to arrange to and from transportation for their group or groups. The directions are printed on the backside of event flyer provided herewith. The phone number for park information is (914) 864 – PARK.
8. Upon arriving at the main stage location the group leader must register with the cultural program coordinator and obtain specific instructions regarding their item(s).
9. It is the responsibility of the group leader to collect and ensure that all participants are waiting & present in a designated area, ready to perform in accordance with the instructions provided by cultural program coordinator.
10. Item(s) cannot be delayed once the specific schedule has been given.
11. If an item requires any special equipment, sound system arrangement or extra power needs, this must be pre-arranged. Last minute request will not be met.
12. IACAW is not responsible for any reimbursement due to change, modification or cancellation of any item, schedule or format.
13. IACAW will make fair and reasonable effort to accommodate all items if the rules above have been met and complied with. However, this is not a guarantee.
14. The Cultural Chair reserve exclusive rights to, repeat, modify or cancel any item. No indemnification will be tendered in any form for such action nor will any appeals be entertained.
15. In return for your participation, which we appreciate, each participant and the group leader will be awarded a token or certificate of participation.
